Menjalankan industri:<ul style="list-style-type: none"><li>(i) Industri Produk Farmasi Untuk Manusia Kelompok ini mencakup usaha pembuatan dan pengolahan obat-obatan, suplemen kesehatan, yang berbentuk jadi (sediaan) untuk manusia, misalnya dalam bentuk tablet, kapsul, salep, bubuk, larutan, larutan parenteral dan suspensi, sabun antiseptic serta benang bedah. Termasuk industri produk kontrasepsi untuk penggunaan eksternal dan obat kontrasepsi hormonal, industri alat-alat diagnosa medis, termasuk uji kehamilan, industri substansi diagnosa in-vivo radioaktif, industri farmasi bioteknologi dan industri pembalut medis, perban dan sejenisnya dan kapas kosmetik.</li><li>(ii) Industri Produk Obat Tradisional Kelompok ini mencakup usaha pengolahan macam-macam produk obat tradisional yang bahannya berasal dari tumbuh-tumbuhan, bahan hewan, bahan mineral, sediaan sarian (galenik), atau campuran dari bahan tersebut</li></ul></li></ul>

(iii) Industri Bahan Farmasi

Kelompok ini mencakup usaha pembuatan dan pengolahan bahan obat, bahan pembantu dan bahan pengemas, yang berasal dari bahan kimia, bahan alam, hewan dan tumbuh-tumbuhan termasuk yang berasal dari hasil biologis, seperti bahan obat-obatan, seperti antisera dan fraksi darah lainnya, vaksin dan preparat homeopatik. Termasuk industri substansi aktif obat untuk bahan farmakologi dalam industri obat-obatan, seperti antibiotik, vitamin, salisilik dan asam o-asetilsalisilik dan lain-lain, pengolahan darah, industri gula murni kimia dan pengolahan kelenjar dan industri ekstraksi kelenjar dan lain-lain.

(iv) Industri Bahan Baku Obat Tradisional

Kelompok ini mencakup usaha pengolahan macam-macam ekstrak dan simplisia, sediaan galenik, bahan tambahan atau bahan lainnya, baik yang berkhasiat maupun yang tidak berkhasiat, yang berubah maupun yang tidak berubah, yang digunakan dalam pengolahan obat tradisional, walaupun tidak semua bahan tersebut masih terdapat di dalam produk ruahan.

(v) Industri Kimia Dasar Anorganik Khlor dan Alkali

Kelompok ini mencakup usaha industri kimia dasar yang menghasilkan bahan kimia khlor dan alkali, seperti soda kostik, soda abu, natrium khlorida, kalium hidoksida dan senyawa khlor lainnya. Termasuk juga usaha industri yang menghasilkan logam alkali, seperti lithium, natrium dan kalium, serta senyawa alkali lainnya.

(vi) Industri Kimia Dasar Anorganik Pigmen

Kelompok ini mencakup usaha industri kimia dasar yang menghasilkan bahan anorganik pigment, seperti meni merah, chrome yellow, zinc yellow, barium sulphate, pigmen serbuk aluminium, oker dan pigment dengan dasar titanium.

(vii) Industri Kimia Dasar Anorganik Lainnya

Kelompok ini mencakup usaha industri kimia dasar anorganik yang belum tercakup dalam golongan industri kimia dasar anorganik di atas, seperti fosfor dengan turunannya, belerang dengan turunannya, nitrogen dengan turunannya. Termasuk juga industri kimia dasar yang menghasilkan senyawa halogen dengan turunannya, logam kecuali logam alkali, senyawa oksida kecuali pigmen.

(viii) Industri Kimia Dasar Organik Yang Bersumber Dari Hasil Pertanian

Kelompok ini mencakup usaha industri kimia dasar organik yang menghasilkan bahan kimia dari hasil pertanian termasuk kayu dan dan getah (gum), seperti asam alufamat, asam asetat, asam citrat, asam benzoat, fatty acid, fatty alkohol, furfucal, sarbilol dan bahan kimia organik lainnya dari hasil pertanian. Termasuk pembuatan biofuel, arang kayu, arang batok kelapa, dan lainnya.

(ix) Industri Kimia Dasar Organik Untuk Bahan Baku Zat Warna dan Pigmen, Zat Warna dan Pigmen

Kelompok ini mencakup usaha industri kimia dasar yang menghasilkan bahan kimia organik, zat warna dan pigment dengan hasil antara siklusnya, seperti hasil antara phenol dan turunannya, zat warna tekstil dan zat warna untuk makanan dan obat-obatan.

(x) Industri Kimia Dasar Organik Lainnya

Kelompok ini mencakup usaha industri Kimia Dasar Organik yang belum tercakup dalam golongan Industri Kimia Dasar Organik, seperti plasticizer, bahan untuk bahan baku pestisida, zat aktif permukaan, bahan pengawet.

(xiv) Industri Peralatan Kedokteran Dan Kedokteran Gigi Serta Perlengkapan Lainnya

Kelompok ini mencakup usaha pembuatan peralatan kedokteran dan kedokteran gigi serta perlengkapan lainnya yang belum tercakup dalam kelompok 32501 sampai dengan 32503, seperti kain dan benang steril dan kertas tisu untuk operasi, semen dan penambal gigi (kecuali perekat gigi palsu 20232), lilin gigi dan preparat plester gigi lainnya, semen rekonstruksi tulang.

(xv) Industri Alat-Alat Laboratorium, Farmasi dan Kesehatan dari Kaca

Kelompok ini mencakup usaha pembuatan macam-macam alat laboratorium, farmasi dan kesehatan dari gelas, seperti botol serum/infus, ampul, tabung uji, tabung ukur, kaca sorong mikroskop, cuvet dan dessicator.

(xvi) Industri Kosmetik, Termasuk Pasta Gigi

Kelompok ini mencakup usaha pembuatan kosmetik, seperti tata rias muka, wangi-wangian atau parfum, produk perawatan rambut seperti shampo, obat pengeriting dan pelurus rambut, produk perawatan kuku atau menikur dan pedikur, produk perawatan kulit seperti krim atau lotion pencegah terbakar sinar matahari dan krim atau lotion agar kulit terlihat cokelat setelah berjemur, produk untuk kebersihan badan seperti sabun mandi, deodorant, garam mandi dan obat perontok bulu, krim cukur dan kosmetik tradisional. Termasuk pasta gigi dan produk untuk menjaga higienitas, termasuk produk pengkilap gigi dan perekat gigi.

- b. Menjalankan perdagangan produk dan jasa, termasuk impor dan ekspor, dan juga bertindak sebagai agen, distributor, pemasok dan perwakilan dari perusahaan-perusahaan lain, baik dari dalam negeri maupun luar negeri:

- (i) **Perdagangan Besar Farmasi**  
Kelompok ini mencakup usaha perdagangan besar farmasi untuk keperluan rumah tangga, seperti obat-obatan.
- (ii) **Perdagangan Besar Obat Tradisional**  
Kelompok ini mencakup usaha perdagangan besar obat tradisional atau jamu.
- (iii) **Perdagangan Besar Bahan dan Barang Kimia Dasar**  
Kelompok ini mencakup usaha perdagangan besar bahan dan barang kimia dasar atau kimia industri, seperti tinta printer, minyak esensial, gas industri, perekat kimia, pewarna, resin buatan, metanol, parafin, perasa dan pewangi, soda, garam industri, asam dan sulfur dan lain-lain.
- (iv) **Perdagangan Besar Alat Laboratorium, Farmasi, dan Kedokteran**  
Kelompok ini mencakup usaha perdagangan besar alat laboratorium, farmasi dan kedokteran.
- (v) **Perdagangan Besar Kosmetik**  
Kelompok ini mencakup usaha perdagangan besar kosmetik, seperti parfum, sabun, bedak dan lainnya.

c. Menjalankan jasa:

- (i) **Jasa Pengujian Laboratorium**  
Kelompok ini mencakup kegiatan uji fisik, kimia, biologi, kelistrikan, mekanik dan analisis lainnya dari semua jenis material dan produk yang mencakup kegiatan pengujian di bidang kesehatan makanan, termasuk uji penyakit hewan dan kontrol yang berhubungan dengan produksi makanan; uji akustik dan vibrasi (getar), uji komposisi dan kemurnian mineral dan sebagainya, uji karakteristik fisik dan kinerja material seperti kekuatan, ketebalan, daya tahan, radioaktif dan lain-lain, uji kualifikasi dan ketahanan, uji kinerja dari mesin keseluruhan seperti motor, automobil, perlengkapan elektronik, pengujian perangkat telekomunikasi,

pengujian laboratorium kedokteran, dan lain-lain, analisis kegagalan, uji dan pengukuran indikator lingkungan seperti polusi udara dan air, uji dengan menggunakan model atau maket seperti pesawat terbang, kapal, bendungan dan lain-lain. Termasuk kegiatan operasional laboratorium kepolisian.

- (ii) **Aktivitas Pelayanan Penunjang Kesehatan**  
Kelompok ini mencakup kegiatan pelayanan penunjang kesehatan yang dikelola baik oleh pemerintah maupun swasta, seperti laboratorium kesehatan (Laboratorium X-Ray dan pusat gambar diagnosa lainnya dan laboratorium pemeriksaan darah dan lainnya), gudang farmasi, bank mata, bank darah, bank sperma, bank transplantasi organ dan pelayanan penunjang medik lainnya.
- (iii) **Penelitian dan Pengembangan Ilmu Pengetahuan Alam**  
Kelompok ini mencakup usaha penelitian dan pengembangan yang dilakukan secara teratur (sistematis), yang diselenggarakan oleh swasta berkaitan dengan ilmu pengetahuan alam, seperti penelitian dan pengembangan matematika, fisika, biologi, kimia, astronomi, geologi, botani, zoologi, dan lainnya.
- (iv) **Penelitian dan Pengembangan Ilmu Kedokteran**  
Kelompok ini mencakup usaha penelitian dan pengembangan yang dilakukan secara teratur (sistematis), yang diselenggarakan oleh swasta, berkaitan dengan ilmu kedokteran.
- (v) **Penelitian dan Pengembangan Bioteknologi**  
Kelompok ini mencakup usaha penelitian dan pengembangan yang dilakukan secara teratur (sistematis), yang diselenggarakan oleh swasta, berkaitan dengan bioteknologi.
- (vi) **Jasa Inspeksi Periodik**  
Kelompok ini mencakup kegiatan pemeriksaan suatu desain produk, produk, jasa dan proses. Kegiatan yang tercakup dalam kegiatan ini misalnya pemeriksaan, peralatan tekan, pre-

shipment, proses produksi, pemeliharaan atau perawatan, pemeriksaan periodik mengenai keamanan jalannya kendaraan bermotor. Tidak termasuk jasa inspeksi bangunan atau gedung.

(vii) **Aktivitas Poliklinik Swasta**

Kelompok ini mencakup kegiatan perawatan kesehatan dan pengobatan fisik yang dikelola swasta, baik perawatan secara rawat jalan, maupun rawat nginap (opname), seperti klinik 24 jam.

(viii) **Aktivitas Rumah Sakit Swasta**

Kelompok ini mencakup kegiatan perawatan kesehatan dan pengobatan fisik, baik untuk perawatan jalan maupun rawat inap (opname), yang dilakukan rumah sakit umum swasta, rumah bersalin swasta, rumah sakit khusus swasta.

(ix) **Aktivitas Rumah Sakit Lainnya**

Kelompok ini mencakup kegiatan perawatan kesehatan dan pengobatan fisik lainnya selain yang tercakup dalam kelompok 86101 s.d. 86104.

Conducting industrial business: <ul style="list-style-type: none"> <li>(i) Industry of pharmaceutical products for humans This category includes the business of manufacturing and processing medicines, health supplements, in finished form (preparations) for humans, for example in the form of tablets, capsules, ointments, powders, solutions, parenteral solutions and suspensions, antiseptic soaps and surgical sutures. This includes the industrial contraceptive product for external use and hormonal contraceptive drugs, the medical diagnostic equipment industry, including pregnancy testing, the radioactive in-vivo diagnostic substance industry, the pharmaceutical biotechnology industry and the medical sanitary napkin industry, bandages and the like and cotton cosmetics.</li> <li>(ii) Traditional Medicine Product Industry This category includes the processing business of various traditional medicinal products which</li> </ul> </li> </ul>

ingredients are derived from plants, animal ingredients, minerals, mineral preparations (galenic), or mixtures of these materials in the form of powders, chews, pills, *dodol/jenang*, pastilles, tablets, capsules, liquids, solutions, emulsions and suspensions, ointments, creams and gels, suppositories. This includes the herbal medicine industry such as curcuma, rice, turmeric and other acids.

(iii) Pharmaceutical Raw Material Industry

This category includes the manufacturing and processing business of medicinal materials, auxiliary materials and packaging materials, derived from chemicals, natural materials, animals and plants including those derived from biological products, such as medicinal materials, such as antisera and other blood fractions, vaccines and homeopathic preparations. This includes the industry of active drug substances for pharmacological ingredients in the pharmaceutical industry, such as antibiotics, vitamins, salicylic and o-acetylsalicylic acid and others, blood processing, the pure chemical sugar industry and glandular processing and the gland extraction industry and others.

(iv) Traditional Medicines Raw Material Industry

This category includes the processing business of various extracts and simplicial, galenic preparations, additives or other ingredients, both efficacious and non-efficacious, which change or which do not change, which are used in processing traditional medicines, although not all of these ingredients are still present in bulk products.

(v) Industry of Inorganic Basic Chemical for Chlorine and Alkali

This category includes the business of basic chemical industries that produce chlorine and alkali chemicals, such as caustic soda, ash soda, sodium chloride, potassium hydroxide and

other chlorine compounds. This includes industrial businesses that produce alkali metals, such as lithium, sodium and potassium, and other alkaline compounds.

(vi) Industry of Inorganic Basic Chemical for Pigment

This category includes the business of basic chemical industries that produce inorganic pigments, such as red men, chrome yellow, zinc yellow, barium sulphate, aluminium powder pigments, ocher and titanium-based pigments.

(vii) Other Inorganic Basic Chemical Industry

This category includes the business of inorganic basic chemical industry that has not been included in the basic inorganic chemical industry category above, such as phosphorus with its derivatives, sulphur with its derivatives, nitrogen with its derivatives. This includes the basic chemical industry which produces halogen compounds with their derivatives, metals except alkali metals, oxide compounds except pigments.

(viii) Industry of Organic Basic Chemical Sourced from Agricultural Products

This category includes the business of basic organic chemical industries that produce chemicals from agricultural products including wood and gum (gum), such as alufamic acid, acetic acid, citric acid, benzoic acid, fatty acids, fatty alcohols, furfural, sarbilol and organic chemicals other agricultural products. This includes the manufacturing biofuels, wood charcoal, coconut shell charcoal, and others.

(ix) Industry of Organic Basic Chemical for Dyes and Pigments Raw Materials, Dyes and Pigments

This category includes the business of basic chemical industries that produce organic chemicals, dyes and pigments with cyclic intermediate products, such as the product

between phenols and their derivatives, textile dyes and dyes for food and medicine.

(x) Other Organic Basic Chemical Industry

This category includes the business of Organic Basic Chemical industry which is not yet included in the Organic Basic Chemical Industry category, such as plasticizers, ingredients for raw materials for pesticides, surface active substances, preservatives.

(xi) Furniture Industry for Surgery, Medical Care and Dentistry

This category includes the manufacture of tools or furniture for surgery, treatments, dentistry, and veterinary medicine, such as surgery tables, hospital beds with mechanical equipment and chairs for dental examinations and treatments.

(xii) Industry of Medical and Dental Equipment, Orthopaedic and Prosthetic Equipment

This category includes the manufacture of tools and equipment for medical examinations, surgery, dentistry and veterinary medicine, such as electrocardiograph, dental drill equipment, eye test equipment (including reflectors, endoscopes, etc.), syringes, sterilization equipment, massage equipment, ozone therapy, oxygen therapy, artificial respiratory equipment, orthopaedic and prosthetic equipment (crutches, surgical belts and trussers, orthopaedic corsets and shoes, etc.), medical thermometers, dental laboratory burners, laboratory ultrasonic cleaning machines, laboratories distillation equipment, laboratory centrifuges, bone plates and screws, syringes, syringes, catheters, cannulae and others, dental equipment (including dentist check chairs incorporated with other dental equipment), artificial teeth and etc made in dental laboratories, artificial eyes made of glass and equipment or other fake bodies, such as fake skull, fake eyes and fake body parts.

(xiii) Eyewear Industry

This category includes the manufacturing business of various ophthalmic goods and glasses along with frames, such as sight-assist goggles, sunblock/sunglasses and safety goggles (goggles for holding dust, swimming, diving, welding). This includes the manufacture of eyeglass lenses and contact lenses.

(xiv) Industry of Medical and Dental Equipment and Other Equipment

This category includes the manufacturing business of medical and dentistry equipment and other equipment not yet included in groups 32501 to 32503, such as sterile fabrics and threads and tissue paper for surgery, cement and dental fillings (except denture adhesive 20232), dental wax and preparations other dental plaster, bone reconstruction cement.

(xv) Industry of Laboratory, Pharmacy and Health Equipment made from Glass

This category includes the manufacturing business of various laboratory, pharmaceutical and health equipment from glass, such as serum / infusion bottles, ampoules, test tubes, measuring tubes, microscope slide glass, cuvet and dessicator.

(xvi) Industry of Cosmetics, Including Toothpaste

This category includes cosmetics manufacturing businesses, such as make-up, fragrances or perfumes, hair care products such as shampoos, curlers and hair straighteners, nail care products or manicures and pedicures, skin care products such as sunburn creams or lotions and cream or lotion so that the skin looks brown after sunbathing, products for body hygiene such as bath soap, deodorant, bath salts and hair removal drugs, shaving creams and traditional cosmetics. This includes toothpaste and products to maintain hygiene, including toothpaste products and dental adhesives.

- b. Conducting products and services trading business, including imports and exports, and also acting as an agent, distributor, supplier and representative of other companies, both domestic and foreign:
- (i) **Pharmaceutical Wholesale Trading**  
This category includes a wholesale pharmaceutical trading business for domestic use, such as drugs.
  - (ii) **Traditional Medicines Wholesale Trading**  
This category includes a wholesale trading business of traditional medicine or herbal medicine.
  - (iii) **Basic Chemical Materials and Products Wholesale Trading**  
This category includes wholesale trading businesses of basic and industrial chemical materials and products, such as printer inks, essential oils, industrial gases, chemical adhesives, dyes, artificial resins, methanol, paraffin, flavorings and deodorizers, soda, industrial salts, acids and sulfur, etc.
  - (iv) **Laboratory, Pharmaceutical and Medical Devices Wholesale Trading**  
This category includes a wholesale trading business of laboratory, pharmaceutical and medical devices.
  - (v) **Cosmetic Wholesale Trading**  
This category includes the wholesale trading of cosmetics, such as perfume, soap, powder and others.
- c. Providing services:
- (i) **Laboratories Testing Services**  
This category includes physical, chemical, biological, electrical, mechanical and other analysis activities of all types of materials and products that include testing in the field of food health, including animal disease testing and controls related to food production; acoustic and vibration (vibration) tests, mineral composition and purity tests, etc., tests of physical characteristics and material

performance such as strength, thickness, durability, radioactivity etc., qualification and durability tests, performance tests of whole machines such as motors, automobiles, electronic equipment, telecommunications equipment testing, medical laboratory testing, etc., failure analysis, test and measurement of environmental indicators such as air and water pollution, tests using models or models such as airplanes, ships, dams and others. This includes the operations of the police laboratory.

(ii) Health Support Services Activities

This category includes health support services that are managed by both the government and the private sector, such as health laboratories (X-Ray Laboratories and other diagnostic image centers and blood testing laboratories etc.), pharmaceutical warehouses, eye banks, blood banks, sperm banks, transplant banks organs and other medical support services.

(iii) Natural Sciences Research and Development

This category includes research and development business that are carried out regularly (systematically), organized by the private sector in relation to natural sciences, such as research and development of mathematics, physics, biology, chemistry, astronomy, geology, botany, zoology, etc.

(iv) Medical Science Research and Development

This category includes research and development business that are carried out regularly (systematic), organized by the private sector, related to medical science.

(v) Biotechnology Research and Development

This category includes research and development business that are carried out regularly (systematic), organized by the private sector, related to biotechnology.

(vi) Periodic Inspection Services

This category includes the inspection activities of product design, product, service and process.
